# 6.0 MONTHLY FINANCIALS AND BUDGET

- 6.01 January Financials

January is when the state adjusts payment for ADM. Since our ADM went down, we weren't sure what that would look like but everything came through just slightly reduced. Moved some money over to savings temporarily since we hit \$250,000 and didn't want audit issues. Daycare got a \$7,877 grant for tables, chairs, and a washer and dryer. Money has been received and appliances ordered. We are getting a retention credit and are also due \$17,000 back from overpayment to the federal government. Budget percentages generally look good, the things we are over on are mainly items we won't spend any more money on this year. Joe is working on an application for a line of credit (\$150,000) with Propel; he is hoping to have it complete by this Thursday. If we get the retention credit and apply it fully to the fund balance, we would be over 10% in the fund balance.

For the second daycare room, the room is ready, the job is posted, and we are in the hiring process. We hope to open it ASAP.

7.02 Middle School Update- 57 students
- Osprey Wilds Field Trip- Osprey Wilds

36 students stayed behind and have sub plans and teachers, 22 on the trip are safe and having a blast! Parents can reach staff through talking points and many students have phones. Is there a way to have TLSA post on our FB live updates each day? For middle school enrollment for next year, this might be a good marketing point.
